## INTENTION TO GRANT ELECTRIC POWER PRODUCTION LICENCE

IN ACCORDANCE with section 11 of the Electric Power Act, 1997, the Minister for Energy gives notice of his intention to grant an Electric Power Production Licence to OrPower 4 Inc. Limited under section 123 of the Act. The proposed grant is in pursuance of the recommendations of the Electricity Regulatory Board under section 9 of the Act.

The proposed licence shall authorize and entitle the licensee to generate electric power at, and supply thereof from the licensed power generating station to be known as Olkaria III Geothermal Power Plant, situate within that area of land more particularly described in Appendix 1 of the Geothermal Resources Licence No. 1/99 issued by the Minister on the 4th March, 1999 to the proposed licensee under the Geothermal Resources Act, 1982\* and the Geothermal Resources Regulations, 1990†.

The net electrical output generated by the licensed power generating station shall be delivered to the Kenya Power and Lighting Company Limited under the terms and conditions of a Power Purchase Agreement dated the 5th November, 1999, made between the Kenya Power and Lighting Company Limited and the licensee and approved by the Board.

  - (a) 144 employees declared redundant on 31st March, 1999;
  - (b) 132 employees sent on compulsory leave/redundancy.
2. C.B.A. arrears to all unionisable employees.
3. Clause No. 23 (Medical Treatment) to all the unionisable employees".

## FINAL AWARD

After the court announced its interim award on 13th October, 1999, the parties appeared before the court on 14th February, 2000. The claimants informed the court that the respondents sold a property in Mombasa but failed to pay the workers their dues as awarded. Furthermore the respondents had given another property as security in a High Court action. The respondents denied the allegations and the court asked the Central Planning Unit to carry out a further investigation into the financial state of the respondents.

The Central Planning Unit stated that the sale of properties by the respondents had been difficult as there were no buyers but confirmed that KSh. 500,000 had been paid but the respondents could not raise another KSh. 200,000 due to financial constraints.

The court ordered the parties to appear before it on 10th July, 2000. The claimants again maintained that the respondents were disposing of their properties. Once again the respondents denied this but their representative undertook to check.

The court ordered the respondents to deposit KSh. 200,000 with the District Labour Officer, Industrial Area, on or before 18th July, 2000, and the parties were asked to appear in court on 19th July, 2000. On this date the claimants confirmed that the respondents had paid KSh. 200,000 as ordered by the court.

Once again the claimants made the allegation resale of assets by the respondents but the respondent's managing director who was personally in court strongly denied the allegations.

The claimants asked the court to order the respondents to pay KSh. 2.8 million as ordered by the court and the balance should be paid in instalments.

The respondents strongly pleaded that they were doing their utmost to sell their properties and that they were struggling even to pay their existing employees their monthly wages. The economic downturn had hurt the laundry business as well and they had lost several contracts with the hotels. The managing director informed the court that the other creditors were waiting to move in and liquidate the company and he denied that he had shares in the Giro Bank but added that he was only a director. The respondents made no offer of instalments and wanted the matter deferred. The managing director made a passionate plea to be allowed to stay in business rather than force the company into liquidation.

The court rejected their request to defer the matter and asked them to pay at least KSh. 50,000 per month through the district labour office and that the order would be reviewed in six (6) months.

On 28th August, 2000, the parties again appeared before the court and the claimants informed the court that the respondents had failed to pay the first instalment which was due on or before 19th August, 2000, and that the respondents had also sold a generator. The respondents said they would pay KSh. 50,000 by the end of the month but the claimants rejected the offer.

The court then proceeded to make a final order because the respondents had failed to pay the first instalment and there were genuine grounds for fearing disposal of assets by them. The court ruled that it had no alternative but to order the respondents to pay forthwith the workers all their terminal dues amounting to KSh. 13,752,236.40 less KSh. 700,000 which they have already paid.

The claimants were directed to take appropriate action under the relevant provisions of the Trade Disputes Act to recover the full balance of the amount due from the respondents.

The two Central Planning Unit reports dated 5th September, 1999, marked "A" and 4th May, 2000, marked "B" are part of this award.

- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

*Kenya Gazette*

"D 40. (1) Communications for the *Kenya Gazette* should reach the Government Printer not later than 9 a.m. on Friday of the week before publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the *Gazette*.
