Chakama Location

The whole of Chakama Ranch identified in the Registry Index map as L.R. No. 13472/1 comprising of 20,418 Ha.

This Extension notice shall take effect from 25th Day of May, 2023 from 6.00 p.m. for a period of Thirty (30) days and may be withdrawn or continue in force for such further period as the Cabinet Secretary may, in each case, by notice in the *Gazette*, direct.
