### **LEGAL NOTICE 77 OF 2023**

Published in Kenya Gazette Vol. CXXV—No. 175 on 4 August 2023

**Commenced on 15 June 2023**

#### **1. Citation**

This Order may be cited as the Public (Notification on Prohibition, Possession of Arms and Surrender of such arms) (TURKANA, ELGEYO MARAKWET, BARINGO, WEST POKOT, SAMBURU) (TURKANA, WEST POKOT COUNTY, ELGEYO MARAKWET, BARINGO, LAIKIPIA AND SAMBURU COUNTIES) Extension Order, 2023.

#### **2. Application**

This Extension Order shall apply in the following specified areas in Turkana, Elegeyo Marakwet, Baringo, West Pokot, Samburu and Laikipia Counties.

- (i) TURKANA COUNTY – Turkana South, Turkana East and Loima Sub-counties
- (ii) WEST POKOT COUNTY – Pokot North and Sigor Sub- counties (along the River Turkwel Escarpment)
- (iii) ELGEYO MARAKWET COUNTY– Marakwet East and Marakwet West Sub-counties
- (iv) BARINGO COUNTY – Mukutani, Muchongoi, Bartabwa, Tiaty East and Tiaty West Sub-counties
- (v) LAIKIPIA COUNTY- Olmoran, Ng’arua, Mukogodo and Sipili Divisions
- (vi) SAMBURU COUNTY - Loroki, Baragoi, Wamba (except Wamba Town) and Malaso Divisions (except Suguta Marmar Town)

#### **3. Declaration Period**

This Order shall apply with effect from 17th June, 2023 and remain in effect for a period of Thirty (30) days.

#### **4. Restriction**

Under this Extension Order, there shall be no public gatherings, processions or movement, either alone or as a group during the period of the Extended Notification except as has been permitted in writing by the Inspector-General of the National Police Service.
